Learn the Health Benefits of Massage and Pass it On By Michael S. Stephens (LMT #989)

We have only hit the tip of the iceberg as far as knowing all of the great benefits of massage. But lots of studies are being researched and the positive results of receiving massage are astounding.

For instance, massage can help people coping with Multiple Sclerosis, Parkinson's Disease and heart problems. Therapy helps M.S. patients by reducing stress. The touch stimulus by the LMT helps to override the pain stimulus. It also releases endorphins to reduce physical discomfort as well as the emotional drag. M.S. patients who have had six months of massage showed less signs of brain disease than the control group. People who suffer from Parkinson's Disease have symptoms which include fatigue, depression and muscle rigidity. There was research on Parkinson's which studied two groups over the course of five weeks. One group was given muscle relaxation training classes. The second group only received massage therapy. Both of the groups were found to have real good improvement with their common symptoms of Parkinson's Disease. But, the control group that received massage treatments had even more profound improvement. At times, cardiac patients are encouraged by their heart doctors to get a therapeutic massage. They are also encouraged to get massage for post operation recovery. This is to induce the relaxation process to speed up healing.

Massage therapy is POWERFUL!

An experience of my own involves a 93 year old client. He recently divulged to me that in his 40's, he battled bladder cancer. After the cancer was removed, he had to be administered testosterone treatments on a weekly basis to maintain his male characteristics. Now let's fast forward about 45 years. He said that soon after receiving massage treatments from me, he noticed enhanced characteristics such as more dense beard growth. His doctor told him to keep doing what he was doing. And the doctor took him completely off the testosterone treatments. This is testimony of the significance of therapeutic massage.

LMT's need to keep themselves on top of the common health benefits in our field of practice. And we should keep our clients and potential clients informed. After an LMT works on a client, one should tell them what to expect from the massage and recommend a time for a follow up session. A massage should be on a regular basis. Just like eating right and exercise, massage should be conducted on a regimental basis to get the most benefit from it. Massage wasn't meant to be one and done. Though it is surprising that so many have this attitude, it is up to LMT's to break that cycle of thinking. We have medical studies and testimonials on our side. One idea is to have a printout which has many verified health benefits that you can give to each client as they leave. That way it can stick in their head as they scan over the list from time to time.

ESTABLISHMENT INSPECTIONS—

Under administrative Code 532-x-3-04 (7), an inspection may be initiated by the Board at any time during reasonable business hours. It's never a good time to be inspected, that, I do understand. As the Board's Inspector, I will make every *reasonable* effort to work with your schedule. "Come back next month" is not reasonable, although you would not be the first to give me that answer, and I can't blame you for trying!

Most times the failure of inspection is based upon the following:

- No posting of original licenses: Yes, if you work at two places, original licenses are required to be posted at both locations).
- No proof of current liability insurance: Insurance information does not have to be posted, but proof must be available at time of inspection (the document being at home does not help!)
- Establishment license posted: Yes, even if you are a sole proprietorship, an establishment license is also required and must be posted).
- The bed not being made will not cause you to fail an inspection!

The Board's inspection process is not designed to be punitive nor burdensome; it is designed to protect the public from non-licensed therapist or non-licensed establishments. Inspections are one of the regulatory functions performed by the Board to protect the public.

EXECUTIVE DIRECTOR REPORT

The Board has been busy this year with various tasks, in addition to the daily operations of the Board, by getting more involved in the FSMTB and Federal Tasks Forces. We have also had some changes in the staff and hope that you haven't experienced too much of a delay in your correspondence during this transition. If you have, I appreciate your patience and understanding.

As you are probably aware, we conduct inspections on establishments that are licensed and those that also advertise massage therapy services to the public that may not hold a license. Many of the new establishment applications that we received are generated through the inspection process. Also, please remember that any business that advertises massage therapy services must be licensed by this Board and hold an Alabama Massage Therapy Establishment License. Please report those businesses that continue to operate without a license. We will be glad to assist you.

I also want to remind you that anyone that conducts and offers massage therapy to the public (except for the exemptions in Section 34-43-5, <u>Code of Ala.</u>, 1975.) must be licensed by the Alabama Board of Massage Therapy. The Alabama Board of Massage Therapy and the Alabama Board of Cosmetology work together through our inspection process for those businesses that offer overlapping services. Some Day Spas offer services that are regulated by the Cosmetology Board and there are some Salons that offer services that are regulated by the Board of Massage Therapy. If you are ever in doubt regarding any services you plan to offer in your establishment or business, please contact either or both of the boards for further guidance. We will be glad to assist.

DISCIPLINARY ACTION BY THE BOARD

Case #2015-008

Respondent: Alicia Jones/Serenity Day Spa

License LMT# 2270

February 8, 2016

Allegation: Alicia Jones, as owner of Serenity Day Spa, violated Ala. Code § 34-43-11 for employing an unlicensed therapist to perform massage therapy.

Board Action: A Consent Agreement was issued, fining Ms. Jones \$500.00. Ms. Jones has closed her business and her establishment license is void.

Case #2015-042

Respondent: Spa Rejuvenate/Scott Hicks License# E2234

February 3, 2016

Allegation: Scott Hicks, as owner of Spa Rejuvenate, violated Ala. Code § 34-43-159A(a)(3) for engaging in unprofessional conduct that endangered the health, safety and welfare of the public.

Board Action: A Cease and Desist letter was issued and delivered to the establishment. Subsequently, as a result of the criminal charges, the Board ordered immediate suspension of the Massage Therapy Establishment License.

Case #2015-042

Respondent: Spa Rejuvenate/Scott Hicks

License# E2092

February 3, 2016

Allegation: Scott Hicks, as owner of Spa Rejuvenate, violated Ala. Code § 34-43-159A(a)(3) for engaging in unprofessional conduct that endangered the health, safety and welfare of the public.

Board Action: A Cease and Desist letter was issued and delivered to the establishment. The establishment was subsequently closed.

Case #2016-005

Respondent: Royal Spa/Jun Kim License LMT# 1500

January 26, 2016

Allegation: Jun Kim, as owner of Royal Spa, violated Ala. Code §§34-43-11(a), 34-43-15(a)(3), and 34-43-15(c) and Alabama Board of Massage Therapy Administrative Code Rule 532-X-5-.03(1)(d) for unprofessional conduct.

Board Action: License surrendered.

Case #2016-005

Respondent: Myung H. Kim License LMT# 2535

January 26, 2016

Allegation: Myung H. Kim violated Ala. Code §§34-43-8(b), 34-43-15(a)(3) and 34-43-15(c) and Alabama Board of Massage Therapy Administrative Code Rule 532-X-5-.03(1)(d) for unprofessional conduct.

Board Action: License surrendered.

Case #2016-005

Respondent: Un H. Choe License#: LMT 3302

January 26, 2016

Allegation: Un H. Choe violated Ala. Code §§34-43-8(b), 34-43-15(a)(3) and 34-43-15(c) and Alabama Board of Massage Therapy Administrative Code Rule 532-X-5-.03(1)(d) for unprofessional conduct.

Board Action: License surrendered. (continued on Page 5)

Case #2015-036

Respondent: No Su Yim/Ocean Sauna

License LMT# 1534

January 19, 2016

Allegation: No Su Yim, as owner of Ocean Sauna, violated Ala. Code §§34-43-11(a) and 34-43-15(a)(3), (c) and Alabama Board of Massage Therapy Administrative Code Rule 532-X-5-.03(1)(d) by promoting prostitution.

Board Action: No Su Yim entered into a Consent Order with this Board regarding the alleged violations. Pursuant to said consent order, Mr. Yim has agreed to surrender his Massage Therapy Establishment License and will not reapply for licensure in the State of Alabama for a minimum of three (3) years.

Case #2015-038

Respondent: Chong S. Yu

License LMT# 3293

January 15, 2016

Allegation: Chong S. Yu violated Ala. Code §§ 34-43-8(b) and 34-43-15(a)(3), (b) and Alabama Board of Massage Therapy Administrative Code Rule 532-X-5-.03(1)(d) for unprofessional conduct.

Board Action: Chong S. Yu entered into a Consent Order with this Board regarding the alleged violations and his Massage Therapy license has been surrendered. Mr. Yu is not allowed to reapply for licensure in the State of Alabama for a minimum of three (3) years.
